sents that we the undersigned Lemuel Hecaton, John Sumstun,
Edwin C. Bush, A. J. Kizer, Conrad Mann, Nat C. McLean, H. B. Dural, E. A. J. Cunningham have
have associated ourselves under the act of the General
Assembly of the State of Ohio entitled an act to cre-
ate associations of persons for raising funds to be loan-
ed among their members for building homesteads and
for other purposes to become a body corporate and
to repeal an act therein named, passed May 5th 1868
and the act to amend Section one and two of said
act passed May 9th 1868 and under an act passed
May 1st 1852 entitled "An act to create and regu-
late incorporated companies in the state of Ohio"
to which the first named act is supplementary
as a corporation for the purpose of raising funds
to be loaned among the members and depositors
for building homesteads and for other purposes.

We do therefore certify that the said corporation shall
be known and designated by the name of the Camp
Garrison Building Association of Harrison County, O.
The Capital stock of said Association shall be

One Hundred and Twenty Thousand Dollars,
divided into 300 shares of \$400⁰⁰ each.

The office of said Corporation shall be in Camp Den-

within Hamilton County Ohio where its business shall be transacted.

The annual meeting for the election of officers and Directors shall be held on the first **Monday** in January of each year and the installation of the said Board shall take place on the following **Monday**.
